1. (a) The minutes of the last Governing Body Meeting held on 18th January, 1972 were circulated to the Members and confirmed with the following corrections:

- (b) The following matters arising from the last minutes were reported and approved:

(i) The Registrar, University of Delhi was approached that the employees working in this college are on probation. Therefore, their options for opting in one of the schemes viz. GPF-cum-Pension-cum-Gratuity or CPF-cum-Gratuity may be taken after they are confirmed. The University informed vide letter No.Fin/PGC/71-72/38634 dated 3rd March, 1972 that the options may be filled in by the specified date i.e. 31st March, 1972 irrespective of the fact that they were on probation.

- 3(b) It was decided that case of Shri C.K.Jain,Supt. (Acctts) regarding selection grade of Rs.350-650 may be referred to the University of Delhi and if it is in conformity with the Rules the Governing Body would be pleased to recommend his case for selection grade.

5. It was decided that the maternity leave may be granted to Mrs.Deepa Mathur,Lecturer in Economics from 1.7.72 for 3 months or to the end of 6 weeks from the date of confinement which-ever is earlier as per University Rules.
6. It was decided that Maternity leave may be granted to Mrs.Una Anand,Lecturer in Political Sc. from 30th June,1972 for 3 months or to the end of 6 weeks from the date of confinement which-ever is earlier as per University Rules.
7. It was decided that *Shri* Khurana will discuss with the Municipal Corporation of Delhi regarding the construction of canteen in the college premises.
8. The letter No.F.17/Site/85/71-CW/5208-9 dated 28th March,1972 from the Deputy Director of Education,Delhi regarding the allotment of land for this college was discussed and it was decided that the land for the college may be acquired in the Karol Bagh area depending on the availability and suitability of land for the purpose.

The Governing Body strongly felt that the institution should cater to the needs of the students of Karol Bagh. The Building committee was advised to see the Vice-Chairman of D.D.A. in this connection.
