And

Bharati College, C-4, Dada Satram Mamtani Marg, Janakpuri, New Delhi, one of the top women's college in West Delhi, is a constituent college of the University of Delhi is located in a serene and scenic campus and caters to about approximate 3500 students, offering instruction in eleven disciplines in the Arts and Social Sciences hereinafter called "**Bharati College**" which expression shall, where the context so admits, be deemed to include the successors, executors, administrators or permitted assigns of the SECOND PART.

WHEREAS, NIELIT offers various Training Programmes in the field of IECT to equip the students with necessary knowledge of the key industry practices and skills to be fruitfully employed besides exposure to live projects and hands-on practical training.

WHEREAS, both parties have held discussion and agreed that NIELIT and Bharati College may identify various key areas of cooperation in order to promote Digital Literacy, generate Skilled Technical Manpower and proliferate Knowledge Sharing among faculties of both prestigious institutions.

Therefore, both parties wish to conclude this Memorandum of Understanding (hereafter called "MoU") to co-operate on the activities set forth in this MoU.

A) THE OBJECTIVE

To foster collaboration, share experience, and to facilitate the advancement of knowledge, NIELIT and Bharati College agree to explore the possibility of engaging in the following modes of collaboration and the objectives of this MoU are:

- i. Conduct of Industrial/Summer Training programmes by NIELIT in advanced and upcoming technologies in the areas of IECT and allied verticals with an aim to equip students/faculties of Bharati College with necessary knowledge of the key industry practices and skills

- ii. Joint organization of seminars, conferences, workshops on topics of mutual interest, while extending invitation to each other's faculty to participate therein and the expenses on such account would be finalized by both the institutions on a case-to-case basis.
- iii. Conduct of Faculty Development Programmes by NIELIT for the faculties of Bharati College in niche areas and future skills.
- iv. Conduction of Job fair/ Internship Fair by NIELIT in collaboration with Bharati College for opening the job as well internship opportunities for the students of Bharati College.
- v. Capacity Building of Faculty and Students of Bharati College on NSQF (National Skills Qualification Framework) aligned courses of NIELIT.
- vi. To promote interaction between NIELIT and Bharati College in mutually beneficial areas which so far have been identified above.
- vii. The course will be conducted by the NIELIT for the students of Bharati College and the training completion certificate will be given jointly with the logo of NIELIT and Bharati College on the issued training completion certificates.

The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

B) PROPOSED MODES OF COLLABORATION

RECOGNISING the mutual interest in the fields of research, development, education, training, transfer of technology and dissemination of knowledge on long-term basis.

NIELIT & Bharati College HEREBY agree to establish collaboration according to terms and conditions set out in the following, hereunder.

Cooperation between the two institutions may be established within any field related to academics and research of mutual interest.

INDUSTRIAL/SUMMER TRAINING:

NIELIT will organize industrial/summer training programmes for students of Bharati College in the niche areas looking at the demand of the industry

JOINT ORGANIZATION OF CONFERENCES, WORKSHOPS AND SHORT-TERM COURSES:




FDP:

C) TERMS AND CONDITIONS

1. NIELIT agrees to take students of Bharati College for admission to its Summer/Industrial Training Programmes and other Advanced Training Programmes or any other Training Programme, as deemed fit, in the best interest of the students, mutually decided with Bharati College on a case-to-case basis.
2. NIELIT is implementing SCSP/TSP Scheme of Government of India. Benefits may be extended to eligible SC/ST candidates of Bharati College subject to availability of seats and compliance of norms of the scheme.

3. NIELIT will customize the Industrial/Summer Training programmes offered to students of Bharati College by incorporating NIELIT's trademark strengths along with a special emphasis on Core Concepts of the technologies.
4. The present MoU can be terminated by either party by giving a notice of three months without assigning any reason. In this regard, neither party shall have any claim against the other party and its officials on account of termination of this MoU. However, the responsibilities and duties of both parties in respect of the students already registered for any of the Programmes under this MoU shall not end with the termination of the MoU, and these will remain valid in totality until completion of evaluation of the already registered students and reporting of their results.
5. Programmes may be added/modified/dropped as mutually agreed upon by both parties to keep the bouquet of courses up-to-date with current technology/trends. The Fee structure of the courses is subject to revision from time-to-time. NIELIT will intimate Bharati College about such changes so as to keep students informed about the latest fee structure.
6. There is no financial commitment on the part of the NIELIT or Bharati College to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt with separately.
7. Commencement and duration of the programmes under MoU will be as per schedule mutually agreed upon.
8. NIELIT- reserves the right to cancel registration of the student, not adhering to NIELIT's code of attendance and discipline.
9. Both the parties shall indemnify and keep the other party indemnified and harmless against any and all claims, actions, proceedings by third party (including all costs, expenses, damages/losses) arising out of or in connection with this MoU due to breach of any provisions of this MoU by such party or as a result of any act of negligence/omission or commission on part of such party and/or its employees, agents etc.
10. Relationship between the parties: It is expressly agreed that NIELIT- and Bharati College are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the Party, to pledge the other Party's credit, or to extend credit on behalf or the other Party.
11. Arbitration: In the event of any difference or dispute arising between the parties in connection with or concerning the observance of the terms and conditions or interpretation thereof, the same shall be jointly resolved by Executive Director NIELIT Delhi- and Principal, Bharati
